

## Affidavit of Johnny Samples

I, Johnny Samples state the following: my son James Samples and his children's Human Rights, U.S. and Kentucky Constitutional rights have been repeatedly violated by various officials and attorneys operating in Western Kentucky in such fashion as to be contradictory to Court Procedure and Practice, Federal & State Law. It is my opinion that their unlawful behavior intensified after my son exposed a family court judge that had made the statement "I accept perjury in my courtroom" as well as other injustices on the internet.

### **Incidents of unlawful retaliatory acts against my son (James) and my grandchildren include:**

- **DENIAL OF CONTACT between the children and their dad.** This was done by a judge that had already recused herself previously. Contact between the children and anyone that the children had reported abuse to including me was severed. The courts and social services have gone to great lengths to conceal the addict/negligent environment that his children suffered (as a result of CPS malice) – I have witnessed CPS going so far as to bare false witness in an attempt to conceal the damage they themselves caused.
- During an Emergency Removal hearing where we were trying to rescue his children from an environment of substance abuse, homelessness, physical abuse (as reported directly to me by the children)... **JAMES WAS DENIED THE OPPORTUNITY TO TESTIFY OR ENTER EVIDENCE** due to the malice of the officials & the guardian ad litem. James was blessed to get that hearing "unsealed"!
- **THE G.A.L. FALSIFIED A POLICE REPORT AGAINST JAMES.** According to dispatch records Approx. 45 minutes after we left the courthouse Jennifer Peeler called 911 and fallaciously reported that James followed her to her office to harass and intimidate her. As we departed from the mock hearing where the dad (my son), James was not allowed to testify or present evidence to protect his children, the same mock trial that was presided over by a judge that had previously recused herself..
  - James was upset and neglected to turn his recorder off (it's a good thing),
  - James, his mother and I departed from the courthouse in the same car (I was the driver) we never went to the US Bank or near Jennifer Peeler the G.A.L.,
  - We left the courthouse and went to the Hendron Lone Oak Elementary School, the Barkley Regional Airport and then on to the Cracker Barrel...
- James' Attorney Shannon Powers **refused to provide James a copy of discovery**. Presumably to protect his colleague Jennifer Peeler. It took James hiring another lawyer and a total of NINE MONTHS for him to obtain a copy of the discovery (taking that long to provide him with discovery is a clear implication of a cover-up --- 9 months to receive discovery is unheard of).

- James posted bond and was quickly **arrested on two additional bogus charges** (one of which was falsifying a police report) of which he has ample proof of his innocence and furthermore has posted online a preponderance of evidence, accusing the arresting agency of involvement in a series of crimes (theft, vehicular thefts, drugs dealings...). Their crimes also included framing James for bogus crimes as retaliation for exposing them. James also discovered that **Deputy David King has a substantial history** of being sued and fired repeatedly for identical misbehavior.
- From the fore mentioned - James **faced up to 16 years** of incarceration stemming from those 4 bogus charges - **JAMES WAS NEVER ASKED SO MUCH AS 1 QUESTION FROM ANYONE CONDUCTING ANY SORT OF "INVESTIGATION"!**

Had there been an investigation of any sort James' mother and I could have explained that he left the courthouse with us. James could have presented the investigating officer with recording from within the courthouse to sometime after.

I retired from the Department of Corrections, I served as a Sergeant at the Kentucky State Penitentiary and I retired serving as Probation and Parole Officer. I have never seen corruption like I have witness unfold in the courtroom and by officials and law enforcement officers operating 180 degrees from just. I'm confident things will continue to escalate as my son continues to expose them. I truly hope my son can successfully sue and receive compensation for him and his children due to the harassment, loss of income and loss of liberties that he and his children has had to endure.
